Inside red boundary operator will have 19 gaps to be clearcut 80' radius from blue/red center trees, operator will estimate 80' radius by equipment size. Slash from gap needs to stay in gap, hand limb & top and or walk delimber to each gap. Skid trails have been blue flagged between gaps to minimize residual tree damage. Operator should minimize skid trail width as much as possible and utilize main vein skid trails between gaps and to landing, operator and forester can realign skid trails as needed.


